## Unofficial Election Results Update for the City of Davis May 2, 2023, All-Mail Ballot Special Municipal Election

(Woodland, CA) Yolo County Assessor/Clerk-Recorder/Registrar of Voters Jesse Salinas announced the first post-Election Night ballot count and unofficial election results update for the City of Davis May 2, 2023, All-Mail Ballot Special Municipal Election.

The most recent unofficial results for the City of Davis May 2, 2023, All-Mail Ballot Special Municipal Election as of Thursday, May 4, at 2:11 p.m. are available here:

<https://www.yoloelections.org/election-returns>. Please note, election results are not final until the election is certified. All results posted until certification are unofficial results. The next unofficial election update will be Tuesday, May 9, by 5:00 p.m. and will include all ballots received on Election Night and received through the mail by 5:00 p.m. on May 5.

Unsigned identification envelope and signature verification statements have been mailed to voters whose signature on the vote-by-mail return identification envelope was challenged by the Elections Office. Challenges occur when the envelope is missing a signature or the signature does not match the signatures on file in the voter record. The Unsigned Identification Envelope Statement and Signature Verification Statement forms are available below and must be returned to the Elections Office by 5:00 p.m. on Monday, May 15, 2023.
